**MEMBERSHIP FEES**

The membership year of this U3A is 1<sup>st</sup> April to 31<sup>st</sup> March, and all subscriptions become due for renewal on 1<sup>st</sup> April each year.

**Annual membership is £13.00.**

If joining after November, membership 1<sup>st</sup> December 2015 to 31<sup>st</sup> March 2016 is £6.50.

These rates include a £3.50 capitation fee to our national organisation, The Third Age Trust, which provides a wide variety of services and benefits, including liability insurance cover.

If Penrith and North Lakes is the second or subsequent U3A you are joining, capitation can be waived if you can supply proof of membership of another U3A. This applies to a full year subscription only, reducing it to £9.50.

You can gift-aid your membership fee. A separate gift-aid form is enclosed.
